Epidemic

The prevalence of substance use disorders in LGBT communities in terms of sexual identity, sexual attraction, and sexual behavior will be presented along with possible explanations of these epidemiological findings. The session will then explore the many facets of the crystal methamphetamine epidemic including its connection with HIV/AIDS and Body Dysmorphic Disorder. We will review the current thinking on psychosocial and pharmacological treatment options, and will critically examine primary and secondary prevention efforts.

Addicted patients present unique problems for the treating clinician: denial and unanticipated patient-generated relapse. Both make treatment difficult to initiate and sustain. Network Therapy is designed to bolster the physician's ability to overcome these troubling problems. It involves engaging several people close to the patient—immediate family members and/or friends to participate at intervals in the ongoing treatment process. The presentation will describe this technique and include video illustrations.

The number of individuals with marijuana-use disorders is over twice that of any other illicit substance, with more people seeking treatment for marijuana dependence than for any other illegal drug in the US. Marijuana abstinence proves to be a challenge for a subset of the population and pharmacological treatments to help patients achieve and maintain abstinence are lacking. This presentation will describe findings from controlled human laboratory studies designed to investigate the effectiveness of potential pharmacotherapies to attenuate marijuana withdrawal symptoms and relapse to marijuana use.

Overdose Prevention with Community Based Naloxone: An Update Sharon Stancliff, MD

In 2006, it became legal for non-medical people to carry and use Naloxone to prevent an opioid overdose from becoming fatal in New York State. To date, over 90 programs in NYS have registered and overdose reversals have happened in a variety of settings including drug treatment. Nationally Naloxone distribution has become mainstream; federal agencies are now promoting this intervention. Participants will be updated on local and national implementation and will learn how their own agencies can become involved.
