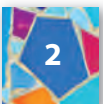

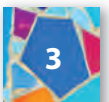

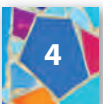

E1: ADVANCED ISSUES IN CHILD SEXUAL ABUSE—*Debra Esernio-Jenssen, Barbara Knox*

Important current and emerging issues in child sexual abuse—what’s new, what’s novel, and what needs improvement. Included will be a review of the current scientific literature regarding timing and types of forensic collections, advances in sexually transmitted infections (STI) testing including current recommendations, and the significance of anogenital findings. In addition, updates of child trafficking and the medical evaluation will be reviewed. Finally, sexualization of children in the media and how it relates to child sexual abuse will be explored.

E2: INTERVIEWING RELUCTANT CHILDREN: RESEARCH AND PRACTICE IMPLICATIONS—*Julie Kenniston, Patti Toth*

Explore the different digital media that children might be exposed to in sexual exploitation and child abuse cases, manage your victim from investigation to trial and protect your victim in the age of digital technology including text messaging, internet, and social networking sites. The multi-disciplinary team can work together to manage victims as they navigate their way through the criminal justice system. Sometimes digital technology is used in an attempt to discredit victims, outlining prosecutors’ best practices to prevent attacks, and the way to manage them when they occur.

E3: TAKE THREE-COGNITIVE PROCESSING: ADVANCED CLINICAL STRATEGIES FOR THE COGNITIVE BEHAVIORAL THERAPY (CBT) TRAUMA THERAPIST—*Monica Fitzgerald, Marcela Torres*

Seasoned clinicians often voice challenges and frustration helping maltreated and trauma-exposed youth and their caregivers combat distorted, inaccurate, and unhelpful thinking patterns related to their trauma experiences. This institute offers specific cognitive restructuring strategies and techniques (e.g., Socratic Questioning, Responsibility Pie, Best Friend Role Play, evidence gathering and thought experiments) to help youth and caregivers contextualize and make meaning of traumatic experiences. Specific steps and innovative strategies will be taught, modeled, and practiced in this session with challenging clinical case examples. Therapists are encouraged to bring real case examples of problematic thinking to practice applying new strategies within small and large groups. All therapists using Cognitive Behavioral Therapy (CBT) interventions will benefit from strategies offered, and clinicians who are familiar with Trauma-Focused Cognitive Behavioral Therapy (TF-CBT) will learn how to skillfully incorporate these cognitive processing techniques into the implementation of the model. Audiotaped and videotaped clinical examples will be used to demonstrate skills. Therapists will leave the session equipped with fresh ideas and skills to apply to their complex trauma cases involving children of varying ages (preschool to adolescent).

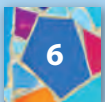

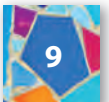
Sharon Behrens, adoptive & foster parent, discovered the miraculous ability of children to heal through her own experiences raising Mia.

**BEYOND KALE AND PEDICURES:

We now have over 20 years of research on Secondary Traumatic Stress and Compassion Fatigue. This presentation will review what's new and what works to reduce the cost of caring.
